### Telia Operator Broadband Services

#### Ethernet network interface

Ethernet network interface is Metro Ethernet area-specific single mode optical 1 Gbit/s or 10 Gbit/s single mode optical interface with Telia's backbone interface. The transmission link from the Ethernet node to the customer is charged separately.

In addition, the customer may choose between two SLA levels, which are subject to an additional charge: Standard and Gold. The basic level, minimum level, is included in Ethernet network interface monthly charge. Standard and Gold SLAs are priced using Telia Ethernet price list.

#### L2-core transfer service

The L2 core transfer service is used, when the Ethernet drain access of the service provider is not located in the same Ethernet service area as the ADSL/G.SHDSL/G.SHDSL.bis/FTTB/FTTC/FTTH subscription. The service is automatically added to the order, and it is subject to a separate charge.
